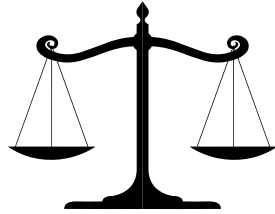

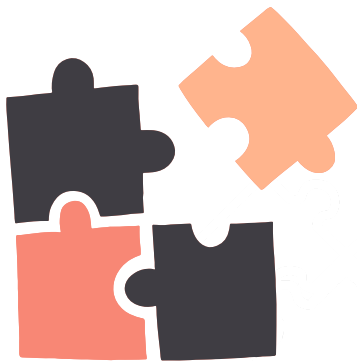

In addition to direct representation of clients and fighting for the rights of our clients in court Orders, The Way to Justice also supports our community partners on their cases! One of our community partners, Freedom Project, is a community-centered and culturally-responsive organization that seeks to partner with individuals and communities to help remove systemic barriers. On October 28th, team members, Josiah and Cameron, attended a Blake Resentencing Hearing in Pierce County Superior Court to show community support for Freedom Project and to gain insight on how Resentencing Hearings are happening on the West side of the state.

The Way to Justice is building an advisory board comprised of individuals who have been impacted by *State v. Blake* to help guide our work.

We are seeking input from individuals who were convicted of simple possession of a controlled substance under former RCW 69.50.4013, which was invalidated as unconstitutional and void by our State Supreme Court in their 2021 decision, *State v. Blake*. Participating Advisory Board members will receive \$20/ hourly stipends, mileage reimbursement, and leadership opportunities.
